



CAMPGROUND RULES

Blue Springs . Jacomo . Longview

To ensure the safety, comfort, and enjoyment of our campers, and to maintain the beauty of our parks and campgrounds, we ask that you observe the following rules during your stay.

(Your camping permit may be revoked without refund for violation of the campground rules)

Check-in / Check-out:

- Attendants are on duty between the hours of 9am and 9pm.
- Standard check-in is from 2pm to 9pm. Early check-in is allowed, subject to site availability.
- Check-out time is 2pm. Late check-outs are subject to a one night fee. No refunds for early departures.
- Camping fees are charged per camping site.
- A permit is required and will only be issued if there is at least (1) adult 21 years of age or older. The permit must be posted on your campsite post where it can readily be inspected.
- Each campsite (even those associated with group reservations) must be individually registered with the name of the responsible person staying at that campsite.
- Any abandoned property left at the campsite after the scheduled check-out time will be disposed of at the discretion of Jackson County Parks + Rec.

Length of Stay Restrictions and Extensions:

- Tent Camping is limited to a total of 5 days in any 14 day period at all County Campgrounds.
- Camping with Fifth Wheel, Bus, Motor Home, Travel Trailer, Pick-up camper, or pop-up is limited to a total of 14 days in any 30 day period at all County Campgrounds.
- Minimum stay on Holidays is 2 nights unless a single day is all that is available. Recognized Holidays are Memorial Day, July 4th, & Labor Day.
- Extension of your reservation may be possible based on availability and approval by the Registration Office.
- To extend your reservation, payment must be made by 12pm on the original check-out date.

Refunds, Cancellations and Transfers:

- No refunds for inclement weather or early departures.
- Cancellations will be assessed a one night fee.
- All site transfers are subject to a \$10 fee.

Occupancy:

- A maximum of two units is allowed per site with the number of persons not exceeding 5 per site. There may be a trailer and tent, or 2 tents on a site. Each site must have and utilize a camping unit as defined as: Fifth Wheel, Bus, Motor Home, Travel Trailer, Pick-up camper, pop-up, or tent.
- A maximum of two vehicles is allowed per site.
- No campsite may be left unattended unless paid in advance. Jackson County Parks + Rec is not responsible for theft or damage to personal items.
- In order to facilitate emergency evacuation for inclement weather all campers must have an operational motorized vehicle at their camp site for the duration of their stay.

Visitors:

- Up to 2 additional vehicle tags may be purchased each day for a cost of \$5.00 each.
- No more than 10 people, including campers and visitors, may be on a site.
- Visitors must leave the campground by 10pm. All campers and visitors must check in with attendants to obtain and must properly display a visitor's pass. Do not distribute the entry gate access code.

Pets:

- Dogs must be under control and on a leash not to exceed 6 feet in length at all times. No aggressive or barking

dogs will be allowed and dogs cannot be left unattended. Campers are required to remove their pet's waste. The waste must be bagged and placed in the trash cans. No more than 3 pets are allowed.

Quiet Hours and Personal Conduct:

- Quiet hours must be observed from 10pm to 6am.
- Fireworks or amplified music are not allowed at any time.
- Rough, rowdy, or disorderly conduct at any time shall be cause for immediate expulsion from the campground.
- Parents are responsible for the behavior and actions of their children at all times. Children must be accompanied to the restroom by an adult. At NO TIME can persons under the age of 17 be left at the campground unattended.
- Panhandling and soliciting are prohibited in the Park per Jackson County Park Regulation 5010.1

Care and Usage of Campground Facilities and Utilities:

- No person shall damage or deface County property.
- No extension cords shall be run from the restroom or campsites to other campsites.
- Campers shall not stay hooked up to the community water faucets for longer than 15 minutes to fill tanks.
- No dishwashing is allowed in drinking fountains, restrooms, or laundry facilities.
- Washing of laundry is restricted to the laundry facilities.
- Vehicle washing requires the purchase of an additional \$10.00 wash permit.
- No vehicles of any kind may be parked on the grass.

Wastewater and Waste Disposal:

- Failure to maintain a clean, orderly campsite may result in expulsion from the campground and/or forfeiture of all fees paid. A no littering rule is strictly enforced.
- Trash must be deposited in refuse containers. Garbage and pet waste must be wrapped in paper or plastic bags before depositing in refuse containers.
- GRAY water may not be discharged on the ground. Containers must be kept under drains and emptied at areas designated by the campground attendant or park ranger.

Plants and Wildlife:

- No person shall disturb in any way the natural terrain, plants, or animals in the park.
- No feeding of the geese or other wildlife is permitted.
- No objects may be tied to or hung from any tree or post.

Fires:

- Fires are permitted only in stoves or fire grills, cannot be unattended, and must be properly extinguished.
- **No outside firewood is allowed.** No exceptions.

Recreational Equipment and Vehicles

- No person shall operate an all-terrain vehicle, including scooters, golf carts, etc. in the campground.
- Radio Controlled vehicles of any kind are not permitted.
- Bounce houses and/or outside vendors are not allowed.
- No pools or water games are allowed at the campground.

Alcohol Possession and Use:

- No person under the age of 21 years shall possess or consume any alcoholic beverage in the park.
- Any person in a state of intoxication may be evicted from the campground and removed from Park property.
- No kegs are allowed in the campground.
